ORDER SCHEDULING SECOND WORKSHOP

THIS MATTER comes before the New Mexico Public Regulation Commission (the “Commission”) upon the Commission’s own motion and upon the recommendation of the Community Solar Action Team.

Whereupon, being duly informed,

THE COMMISSION FINDS AND CONCLUDES:

1. During the 2021 session, the Legislature passed Senate Bill 84, the “Community Solar Act,” which was signed by the Governor on April 5, 2021, and will become effective on June 18, 2021 (the “Act”).
2. As described in its long-form title, the Act prescribes requirements for community solar facilities, subscriber organizations, and subscriptions; prescribes requirements for administration of a community solar program; provides that renewable energy certificates associated with a community solar project are the property of the qualifying utility; provides exceptions for native community solar projects and rural electric cooperatives; directs the Commission to adopt rules to implement a community solar program; and allows the Commission to establish and collect reasonable application fees from subscriber organizations.
3. On May 12, 2021, the Commission issued its Initial Order, opening this docket for a rulemaking pursuant to the Act, briefly describing the role of Strategen Consulting, LLC (“Strategen”) in the rulemaking, and briefly describing the Community Solar Action Team (the “Team”).

4. On May 26, 2021, the Commission issued its Order Scheduling Workshop; Notice and Instructions to Rulemaking Participants, setting the initial workshop in this rulemaking for June 24, 2021, pursuant to the recommendation of the Team.

5. The initial workshop was held on June 24, 2021. The workshop was followed by meetings of the working groups, which groups were created to address particular topics in the rulemaking.

6. The Team recommends that the Commission schedule a second workshop on August 27, 2021, to be held via the Zoom online platform, and to commence at 9:00 A.M.

7. The Commission has jurisdiction over this matter.

8. The Commission finds that the recommendation of the Team should be adopted and that the second workshop in this matter should be scheduled accordingly.

IT IS THEREFORE ORDERED:

A. A workshop is hereby scheduled for **Friday, August 27, 2021, at 9:30 A.M.**, to be held via Zoom. The workshop is anticipated to last until approximately 2:30 P.M., but participants should be prepared in case the workshop runs beyond that time. The Team will provide further information concerning the workshop to rulemaking participants in the near future.

B. Any person who may wish to participate in the workshop must notify the Zoom host, Isaac Sullivan-Leshin, no later than **12:00 noon on Thursday, August 26, 2021** by sending an email to isaac.sullivan-leshin@state.nm.us that lists the name, email and organization (if applicable) of each person who wishes to participate. Anyone who does not provide notice by this signup deadline will not be allowed to enter the Zoom meeting but will still be able to watch the workshop via livestream on YouTube. A Zoom invitation to the workshop will be sent out on August 26, 2021 to all persons who provide sufficient and timely notice as per this paragraph. The

Zoom invitation will include a call-in phone number for those participants who are unable to use the Zoom platform.

C. This Order is issued by the Chair of the Commission or by a single Commissioner as authorized by 1.2.2.30 (B) NMAC of the Commission's Rules on Procedure.

D. Any person who does **not** wish to participate in the workshop but merely view the workshop may do so via streaming video on the Commission's website at www.nmprc.state.nm.us.

E. This Order is effective immediately.

F. A copy of this Order shall be served upon all persons listed on the attached certificate of service via email, to the extent that email addresses are known, and if not known, then by regular mail.
